## THE MIDWIVES' REGISTRATION BILL. To the Editor of "The Nursing Record."

Sir,-Our attention has been called by Dr. Leslie Phillips, Hon. Sec. of the Medical Defence Union, to the statements of Dr. Rentoul at the close of the article under the above heading on page 226 of your issue of 30th April last.

The suggestion there made by Dr. Rentoul, attributing unworthy motives to Mr. Lawson Tait in his capacity of President of the Union, is too absurd to require either denial or argument.

It is only right, however, to state that the course adopted by the Council of the Union in declining to defend Dr. Rentoul in the County Court action for  $\pounds 6$ , to which he refers, was taken in accordance with the unanimous vote of an exceptionally large meeting of the Council. In taking this course the Council simply acted upon the advice which we, as solicitors to the Union, have uniformly and repeatedly given in similar cases-viz., that the defence of mere debt collecting actions is not within the province of the Union,-
