from that point of view there are few things in this world that would not stand condemned.

The Badge is a bond of membership; let the holders be jealous ever of the honour of our Association, true to each other, steadfast to our cause. There are foes to face and fields to win ; what better augury for victory could we have than in the union that has made Nurses a force in the present, and, if they so will it, a far greater force in the future? That any Nurse can stand aloof from our union marks an indifference to the true interests of her profession that might almost be called a reproach; at least, such it appears to a staunch supporter of our Badge, like—Yours very truly, JUSTITIA.
