The condition of affairs which have now been made public through the Press have been well known for long to all who have the true interest of the Nursing, and, in consequence, the Nurses, at heart. The Resident Staff, who know more of the domestic details of a Hospital than any other officials, are one and all in entire sympathy with the Nurses. The Committee of Management are now inquiring into the matter, and it is to be hoped there will be none of the hard-swearing and counter-swearing which was not the least significant episode in connection with the London and Homerton Hospitals *exposés*, and which seems a marked feature in most Hospital inquiries.—I remain, &c.,
