## Outdoor Maternities, &c.

PERSONALLY, and on behalf of the "SANITAS" COMPANY, LIMITED, I respectfully beg to strongly protest against the rules for the use of Antiseptics which have been issued by the Committee of Management of the General Lying-in Hospital.
