WE have received, from several of our readers, copies of the *St. James's Gazette* for November 29th, containing an account of "a Chat with Miss PHILIPPA HICKS," and various expressions of opinion concerning the views therein expressed. We are bound to confess that we share the astonishment with which the public, and the indignation with which Nurses, have perused Miss HICKS'S remarks. Our contemporary has, on several occasions, proved its innocence of the question of Registration, and the actual meaning and effect of that measure, and no surprise will therefore be felt that it has been completely misled on this occasion. Its interviewer had a faint glimmering idea that a published list of trained Nurses might perhaps be useful to the public; that it might, perchance, be well that the sick should have some protection against the "ignorant women and even the criminals who now are able to call themselves trained Nurses"; but he considers that "the intelligent views of Miss PHILIPPA HICKS places the matter in a very different light." Miss HICKS could "only give him five minutes," said she was quite opposed to the registration of Nurses, and went on to prove why she held that opinion.
