FALSE CERTIFICATES.

showed, last week, that the system which certain institutions pursue in undertaking to train their Probationers for two or three years, as the case may be, and then, before that time has expired, sending these women out as private Nurses, was eminently unjust to them as well as to the public who thus received the services of women who were not as thoroughly trained as their employers had been led to expect. We showed, moreover, that this system was partly concealed, and made much worse, by the fact that these Hospitals granted, to such Probationers, certificates, stating that for the full term of training they had been employed, and had been taught, in the wards of the Institution. We complained that this was a flagrant violation of good faith, and, moreover, was itself injurious to the Nurses who obtained such misleading testimonials.

It has recently come to our knowledge that several of these women, when they applied for enrolment upon their professional Register, were found to be ineligible, because their certificates were untrue, and because they had consequently not received the entire three years' Hospital training which was necessary. In other words, the Hospitals who pursue this system are not only breaking faith with their Probationers during their term of training; they are not only depriving them of the benefits and educational opportunities which they promised to give to their pupils, and using them instead as a source of revenue; they are not only deceiving the public by sending them an inferior article to that for which they ask; but beyond all this, they are permanently injuring the future career of their Probationers.
