## Mursing in the Wilds.

E cull the following instructive report of a meeting of a Devonshire Board of Guardians from the *The Observer and Chronicle*; it throws a strange light upon the management of the Nursing of our sick paupers in Workhouses; and we are glad to observe that the Nurses selected in this case protested against the inefficiency of the arrangements for the Nursing of the inmates. Are there no women in Newton Abbot—after the late gruesome exposures in the Workhouse—sufficiently humane and sufficiently courageous to offer themselves as Guardians of the Poor?

"Newton Abbot has attained considerable notoriety lately by the evidence which has been adduced during the inquiry relative to what has been termed 'The Workhouse Scandals.' We gave a summary of that evidence in our edition last week. The following extract from a report of the last meeting of the Board of Guardians for Newton Abbot will doubtless be read with interest. The recent official inquiry, it will be also remembered, related to allegations concerning the treatment of inmates in the Workhouse. Our quotation is from an ordinary meeting of the Board:—

Six Nurses had been invited to attend the board meeting, three being applicants for the post of Head Nurse, and three for that of Assistant Nurse. Their names were—Miss M. Kift, Cleobury Mortimer Union; Miss K. Denton, Edgbaston; Miss E. A. Sanders, Medway Union (Head Nurses); Misses A. E. J. Thompson, Deptford; E. M. Wrench, Stroud; and C. Hughes, Brondesbury. The board proceeded to have the applicants before them, one at a time. After Miss Kift had left the room,

Mr. Vicary asked if she was properly qualified?

The Chairman: Yes.

Mr. Vicary: I don't think so.

The Chairman: That will do. I think she is the best candidate of the lot (uproar).

Dr. Ley protested. He had never heard anything so monstrous in his life.

Mr. Tripe asked the Chairman to do things in a proper way; and the Chairman retorted that he was not going to be interrupted. Then he commenced to proceed to the election.

Dr. Ley rose.

The Chairman: You have no right to speak.

Mr. Snow: You have no right to speak after the remark you made.

Mr. Smerdon: Behave yourselves like men.

The Chairman: The behaviour of Mr. Snow is perfectly rascally. (Disorder, and 'What about yours?')

Mr. Ley: It is disgraceful. (Uproar, in the midst of which a member shouted to the Chairman 'Keep your hair on.')

The election eventually was proceeded with, the result being—Sanders 41 votes, Denton 8, Kift 1 (the Chairman alone voting for her).

Miss Sanders was then called in, and the Chairman informed her that she had been appointed.

Miss Sanders: I have been round the house, and two Nurses could not conscientiously do the work there is to be done here.

The Chairman: Do you decline the office?
