6. Applications for Membership or Associateship shall be made upon forms provided for that purpose; and the election shall be determined by vote at a Meeting of the Council upon the recommendation of the Executive Committee and after due inquiry.—Pro-posed by Mrs. Bedford Fenwick, seconded by Miss Robertson.

7. The Honorary Offices of the Council shall be a Chairman, three Vice-Chairmen (one of whom shall Charman, three Vice-Chairmen (one of whom shall retire annually in rotation and not be eligible for re-election for at least one year), and an Honorary Secretary, who shall also act as Treasurer. The Honorary Officers shall be elected at the Council Meeting in October of each year.—Proposed by Mrs. Bedford Fenwick, seconded by Miss Hogg.

8. That the Council shall meet once a quarter in the months of October, January, April, and July.— Proposed by Mrs. Bedford Fenwick, seconded by Miss Ridley.

9. The Council Meeting, in October, shall elect twenty Members to form an Executive Com-mittee (one-fourth of whom shall retire annually shall in rotation), which shall carry on the business of the Society, and shall organize such Meetings and Congresses as it may be decided to hold.—Proposed by Miss Robertson, seconded by Miss Rogers.

10. The Executive Committee shall meet once in each month, or as often as may be necessary, at such times and places as may be decided upon, to receive applications for Membership and Associateship, and do such other business as may be necessary.— Proposed by Miss Hogg, seconded by Mrs. Bedford Fenvice Fenwick.

11. No new bye-law may be made, nor may any standing bye-law be amended or rescinded, except at Council Meetings, nor unless full notice of such proposed alteration, addition or omission, shall have been given to every Member upon the notice convening the said Meeting .- Proposed by Miss Butler, seconded by Mrs. Okell.

The Chairman then put the Bye-Laws en bloc to the Meeting, and they were passed unanimously.

The Council then proceeded to elect the Honorary Officers and the Executive Committee. The following names were proposed subject to their consent to act :--

This was seconded by Miss Henrietta Kenealy, and was carried unanimously.

Tea and Coffee were served in the Library, and all present expressed themselves deeply indebted to Mrs. Strong for coming so far to read her most thoughtful and inspiring paper.
