But with all my amazed interrogation I should be sorry to do Mr. H. C. Burdett an injustice. Perhaps, after all, with an enterprise characteristic of journalism, he—in his corporate capacity—is anxious to resuscitate, and float into neurlarity the house house of tradition the Nurse

corporate capacity—is anxious to resuscitate, and float into popularity, the heaven-born Nurse of tradition—the Nurse who, as we all know, "was born and not made," and who was quite independent of "training" and scientific method in the art and craft of Nursing. I love tradition, and I trust this is Mr. H. C. Burdett's intention, though it is hardly fair to the heaven-born Nurse not to mention it, nor does it appear to be on such "busi-ness-lines" as I, for example—a simple-minded Nurse— would have associated with "the city," not to have stated such an important fact on the prospectus.




