It is interesting to learn that Miss Elinor Lyon, the Lady Superintendent of the Meath Hospital in Dublin, and head of the Red Cross Sisters in Ireland, who has lately become a member of the Royal British Nurses' Association, is one of what is called a "Nursing Family." She is an Irish lady by birth, a native of Westmeath, and was trained at the Royal Southern Hospital, Liverpool, and became at once Lady Superintendent of the Children's Hospital in Dublin, where she passed three years of active service, after which she was appointed Lady Superintendent of the Meath Hospital, a very arduous post, which she has now filled for the past eleven years. Her sisters, Alison, Meta, and Bessie, are engaged respectively in charge at the Children's Hospital, Nurses' Home, Harcourt Street, and Convalescent Home, Bray. The Committee of the Red Cross Order in Dublin have started a pension fund by which their Nurses may benefit in old age, or if disqualified from earning their livelihood during earlier years, through accident or ill health; this is an excellent arrangement, and one which it would be advisable for many other institutions to follow, and it is doubtless a source of inducement to ladies intending to join the ranks of sick Nurses in Ireland.
