## To the Editor of " The Nursing Record."

DEAR MADAM,-It is cheering to find that you take a more hopeful view of the ultimate outcome of the present unsatisfactory condition of our Associa-tion than your correspondents, "A Member of no Importance," and "A Member of the Council."

May I remind your readers that the removal of the honoured names of the founders of the Royal British honoured names of the founders of the Koyal British Nurses' Association from its governing body is not yet an accomplished fact, and that should this dis-grace come upon us the blame will rest upon every individual member of the Association (who has an opportunity of knowing the truth) who does not protest against this injustice by altering the voting list sent to her. That this list should have been drawn up by the Hon. Medical Secretary, and pre-sented to the Council without one word of explana-tion striking as it does at the root of our Constitution tion, striking as it does at the root of our Constitution, and issued to the members of the Corporation again without impressing upon them the contemplated change, so that many members may have already signed and returned their voting lists quite innocent that by so doing they are removing from all share in the management of the Association the women they most honour and respect, and to whom they owe the deepest debt of gratitude, is an act which I feel sure every member of the Association will join with me in condemning in the most emphatic terms.

But words are useless-let us act. Might I suggest that every member who has not yet returned her voting list to the office should write in the following names at the bottom of the suggested list of Matrons :-

Miss Louisa Hogg,

Miss Catherine Loch,

Miss Isla Stewart, Miss G. Thorold,

Miss Gertrude Rogers, and

Mrs. Ethel G. Fenwick,

and let each member be careful to date and sign the list.

Upon referring to the *Nurses' Journal*, page 40, the Chairman, at the special Council Meeting of May 10th, is reported to have stated that to retain these ladies' names on the new Council list "would be a contravention of the Bye-laws." This may be so at the present moment, owing to the unbusiness-like manner in which they have been drawn, but what we members have got to do is to alter the Bye-laws, making them conform to the original Constitution, and not to sit down and calmly submit to the present chaotic wording of these laws. The Charter does not restrict the number of ex-officio members, therefore if it is the will of the members in a meeting of the Corporation that the honourable contract entered into with the ex-officio matrons be maintained, the ambiguity of the wording of the Bye-laws constituting the General Council must be made to conform with that constituting the Executive Committee. Feeling sure that the majority of my fellow members will be warmly in sympathy with this line of action,
