gift of \pounds 100, there was \pounds 103 at the bank, and the liabilities at the end of the year would, he thought, be \pounds 300, against which he hoped about the same amount would be collected.

would be collected. Dr. Fenwick said that he was content to point out to the Council that, excluding the unexpected gift the Association would have had only \pounds_3 in the bank and large liabilities at the present moment, and that this absolutely justified his prediction. He must once more point out to the Council that the Asso-ciation was spending at least \pounds_500 a year beyond its assured income and that this grave financial fact its assured income, and that this grave financial fact must be faced and remedied. Dr. Fenwick called attention to the proposed new Regulation, and showed that without effecting the slightest good it would be most detrimental to the training of Probationers in the great majority of the hospitals in the country which have less than forty beds. He proposed that the Regulation should continue unchanged, with the omission of the waiver clause. Considerable discussion followed, in which Miss Mollett, Miss Burr, Mrs. Okell, Miss Poole, Dr. Thorne, Mr. Pick, Mr. Bru-denell Carter and the Chairman took part, and finally Dr. Fenwick's proposition was unanimously accepted, and the Reports, thus amended, were unanimously passed.

Dr. Calvert did not seek re-election as Treasurer, and Dr. Fenwick proposed a vote of thanks to him for his valuable services, pointing out that he had been compelled to criticise the financial management, but had done so quite impersonally, and had always expressed his sense of the difficulties under which Dr. Calvert had laboured. The resolution was carried by acclamation.

Mr. John Langton, Surgeon to St. Bartholomew's Hospital, was elected as Honorary Treasurer, and Mr. Fardon, Resident Medical Officer of Middlesex Hospital, as Honorary Medical Secretary.

The Vice-Chairmen—Miss Thorold, Lady Superin-tendent, Middlesex Hospital, Sir James Crichton Browne, and Mr. Pickering Pick, Surgeon to St. George's Hospital, were re-elected.
