Legal Matters.

BREAY v. THE ROYAL BRITISH NURSES' ASSOCIATION.

IT will be remembered that Mr. Justice North, on May 19th, granted an Injunction in this case, restraining the officials of the Royal British Nurses' Association from expending their funds, in defending an action for libel brought by Dr. Bedford Fenwick against Miss Josephine de Pledge, until it had been tried and decided whether the Association under its Charter had the power to expend its funds in such a manner. The defendants appealed against this Injunction, and this was heard before Lords Justices Lindley, Lopes and Chitty, on June 17th. The Judges held that Miss de Pledge was employed by a Sub-committee of the Association, who were the proprietors of the Journal, and therefore responsible for whatever appeared in it; that she was acting under the instructions of the Executive Committee in publishing a libel in their Journal, and it was therefore within their power to pay the costs of her defence; that the question practically was one of master and servant, and that the Association being a Corporation did not alter the question of its right to defend those who acted under its instructions. They therefore allowed the appeal. It would be of course improper for us to comment upon the questions at issue in the libel But it is, at any rate, certain that the action. Association has not been consulted upon this matter, because no meeting of the members has been held since the article which is impugned was published; and it is, we are aware, felt by many members of the Association that Miss Breay has performed a very disagreeable and invidious duty in publicly questioning the right of the officials to spend the funds subscribed by the nurses for their own benefit, in legal proceedings brought by one member of the Association against another, and not directly against the Association itself.
