THE Duchess of Sutherland has recently been travelling in the remote districts of Sutherland, and working hard in the interests of the Sutherland Nursing Association. During her tour her Grace has delivered several lectures, and has made a most successful house-to-house visitation. There is at present much ignorance, and consequently much prejudice, on the subject of the aims and scope of the Nursing Association, and the Duchess both on account of her position and her personal popularity was eminently fitted to undertake this campaign.

THE Ophthalmia Committee of the Central London School District have reported that the arrangement which had been made for the training of the Roman Catholic nurses had worked very satisfactorily. They recommended that a charge of three guineas should be made for the maintenance of the nurses during the three weeks they resided at the school.
