some quite unimportant "Institution" may be placed on it. It is perfectly certain that the leading Hospital Matrons who already disapprove of the management of the Association will be still further repelled by such a provision. Irreparable injury would be caused to the Association and its work, while the Bye-Law would enable the officials to place on the General Council and Executive Committee nurses of no standing or influence, who could do nothing but confirm any proceedings taken by the officials.
