The Members' Rights Defence Committee, therefore, submit the following points:-

1. That no necessity exists, or has been shown, for the total re-casting of Bye-Laws, which have served the Association from its foundation.

2. That the proposed Bye-Laws were drawn up by the present officials, viz., the three Vice-Chairmen

the Treasurer, and the Medical Honorary Secretary of the Association.

That the chief effects of these Bye-Laws would be (a) to withdraw definite and important rights accorded to the members under the present Bye-Laws; (b) to break pledges given to the Matrons of the leading Hospitals and to important medical bodies; (c) to make the governing bodies small and totally unrepresentative of the nursing or medical profession; (d) to make the members of those bodies practically the nominees of the said officials, and to make the Executive Committee a small permanent

4. That grave charges of mismanagement of the Association were, last June, made publicly against the very officials who now desire to be given supreme and uncontrolled authority over its affairs. And the said officials have during the last six months conspicuously refrained from exhibiting any inclination or intention to seek for the public inquiry which has been demanded by those who formulated these

charges.

5. That at a large and influential Public Meeting, held on October 13th, at St. Martin's Town Hall,

6. That at a large and influential Public Meeting, held on October 13th, at St. Martin's Town Hall, the following Resolution was unanimously passed, and similar Resolutions have been passed at other Public Meetings :-

"That this Meeting expresses the astonishment, which is widely felt, that the officials of the Royal British Nurses' Association have not demanded a public Inquiry into the grave charges made against their management, because such a reluctance on their part admits of only one explanation. In view of the great public and professional interests which are involved, this Meeting considers that such an Inquiry is imperatively needed, and it, therefore, hopes that all Members of Parliament will support the motion for the appointment of a Select Committee which will be made, next session, in the House of Commons."
