Royal British Aurses' Association.

THE Quarterly Meeting of the General Council was held on Friday, April 15th, at 5 p.m., at 11 Chandos Street, Cavendish Square. Mr. Pick took the chair, supported on the platform by Mr. Langton and Mr. Fardon. As usual, it was noticeable that many of the nurses present wore the Middlesex Hospital uni-

form, and with the exception of Mrs. Okell there were no matrons of important institutions present. The minutes of the last meeting having been read and confirmed Mr. John Langton read the following Financial Report :-- " The Hon. Treasurer regrets that he is unable to forward to the members of the council the audited balance sheet for the year preceding March 31st, 1898, owing to the unavoidable absence from London of the auditor of the corporation." The financial statement for the past year was, however, laid before the council by the Hon. Treasurer, showing the expenditure and receipts for the past year. The accounts had not been signed by the auditor, and, therefore, it will be better not to quote the figures given by 'Mr. Langton. . But, briefly, the accounts showed that the Association began the year with a balance of £144 and ended with a balance of £4, to which Mr. Langton had added a loan or a gift of $\pounds100$. There were, however, debts to the amount of about \pounds_{140} . The adoption of the Treasurer's report having been proposed and seconded, Dr. Bedford Fenwick pointed out that the figures meant that the Association was still impecunious and was still spending far more than its income, The Report was then adopted.

Mr. Edward Fardon, Hon. Medical Secretary, read the following report : "The Executive Committee beg to report that 34 nurses have been registered in the last three months, 27 members have been elected, five have withdrawn, and 2 have died. The Bye-Laws passed at the General Meeting on December 17th, 1897, were submitted for the approval of the Privy Council in due course. Several petitions have been presented to the Privy Council against these Bye-Laws, to which replies have been made. A communication from the Privy Council, dated March 29th, has now been received and laid before the Executive Committee. In this reply, the Privy Council indicate some particulars in which an alteration will be necessary, and these alterations will be laid before the Association as soon as possible. It will be necessary that another General Meeting should be held to sanction any alteration before the Bye-Laws are again submitted to the Privy Council for
