A CHAIR OF CLINICAL NURSING.

Miss Margaret Breay, Hon. Secretary, reported that in accordance with the direction of the Council she had forwarded the following letter to the Warden of Durham University and had received the following replies on the subject of a Chair of Clinical Nursing:

> 46, York Street, Portman Square, 3rd February, 1899.

SIR,-At a Meeting of the Executive Committee of the Matrons' Council, held at the Matron's House, St. Bartholomew's Hospital, under the Presidency of the Chairman, Miss Isla Stewart, it was unanimously decided that the subjoined Resolution should be forwarded to you. May I ask you kindly to bring it before the Governors of the University.

"The Matrons'Council of Great Britain and Ireland an Association of Superintendents of Trained Nurses, desire to draw the attention of the Authoritics of Durham University to the fact that a Chair of Clinical Nursing has been founded by the University of Texas, and that Miss Hanna Kindbom, Matron of the John Sealy Hospital, Galveston, has been appointed to this chair. The Matrons' Council have learnt with much pleasure, that the University of Durham proposes to admit women to its degrees, and they desire to represent to the authorities the desirability of founding a Chair of Clinical Nursing in this country. They consider that in so doing, the University of Durham would give prominence to a subject of great importance in the education of women.

The Deanery, Durham, 4th February, 1899. DEAR MADAM,—I have received your letter with the Resolution passed by your Council, and shall readily submit it to the Senate of the University.

They, however, can take only one step-that is, they will send it on (with or without recommendation, as they may see fit) to the Durham College of Medicine, which has the right to decide all questions about their whole Staff.

I am quite sure from my knowledge of Dr. Philipson, the President of the College, that your suggestion will have kindly reception, however they may decide, for the College of Medicine have already several lady undergraduates, and their degrees with all the other Durham Degrees except theology, are open to men and women on exactly equal terms. Senate meets next Tuesday and the matter will then be set forward one step.
