# The League of St. Bartholo= mew's Murses.

THE following is the text of the circular issued by the Provisional Committee for the foundation of an Association of the certificated nurses of St. Bartholomew's Hospital:— "It is proposed that the Association be called

"The League of St. Bartholomew's Nurses." That the objects of the "League" be :---

a.-By union, to encourage the Members to aim at a high standard of work and conduct.

b.-For mutual help and pleasure.

The qualification for Membership will be the Certificate of the Hospital.

At the commencement the Executive will have power to elect a certain number of Nurses, who, although not holding the Certificate, have filled posts of responsibility in the Hospital. It is suggested that the League be governed

by an Executive and Disciplinary Committee which will manage the business of the League, and will present a Report and a Financial Statement at the Annual Meeting of its Members.

It will enquire into, and lay before the Members when necessary, any case of misconduct which may come under its notice.

The Committee shall consist of a Chairman, Treasurer, Secretary and twelve other Members, to be elected for a term of three years, and afterwards at such periods as the League may determine.

The Annual Subscription will be 2s. 6d.

It is proposed to form a Benevolent Fund which will be maintained by Subscriptions and Donations. The Executive Committee will have power to grant sums either as loans or gifts to such Members as may be in temporary difficulties.

There will be an Annual Meeting for the transaction of business, followed by a Social Gathering.

It is proposed to print, from time to time, a list of Members with their addresses and official positions and such details of their career as they may furnish. It will be sold at a cost which will cover expenses."

The objects of the League must commend themselves to all. We feel sure that very many nurses, who are proud of their connection with this grand old hospital, will welcome the opportunity afforded them of keeping in touch with the training school which they remember with so much affection.
