had been expedited by the Dutch Red Cross to Bloemfontein and Pretoria.

The Hague Gazette has opened a subscription on behalf of the widows and orphans of the Boers who perish on the field of battle. Editor of the above-named journal has appealed to the President of the French League of Women for International Disarmament (Lique des Femmes pour le Desarmement International) at Paris for the furthering of his aim. The President, Princess Wiszniewska, has informed the Hague Gazette of the fact that the Parisian Committee of the League is willing to subscribe for a hundred A meeting of the Board of Management, held lately at Paris, resolved to support this subscription in all ways by sending, with this view, a circular to all the Vice-Presidents, heads of sections of the League, etc.

## The Canterbury Case.

WE notice with pleasure that the Kentish Observer, in referring to our remarks concerning the Kent and Canterbury Hospital, in our last issue, says:—" Whether the allegations are founded or unfounded we are not in a position to say, but it certainly behoves the Committee to take one of two courses-either to give the lie direct to the charges if there is no truth in them, or to remove the causes of the grievances if there is any ground for them." This is the only logical We should advise our esteemed contemporary, however, to investigate the allegations made, so that it may be in a position to have a definite opinion on the subject.

But if the attitude of mind now shown by the Rev. C. M. Amos, is shared by his colleagues on the Board of Management, we are not hopeful that the grave charges made unanimously by House Surgeons, Sisters and Nurses will receive that impartial investigation which they merit. Amos has left the levels of judical calm, in which he should be entrenched at this crisis, and has adopted a hotly partizan attitude, as will be seen from the correspondence which we publish below, and of which, of course, we have taken no notice.

KENT AND CANTERBURY HOSPITAL .- THE COMPLAINTS BY THE NURSES.

To the Editor of the "Kentish Observer."

SIR, -During the past few months there has been a hidden and unchristian agitation carried on by the House Surgeons, Sisters, and Nurses in this hospital against the Board of Management and the Matron. It culminated in a letter from the House Surgeons to the Board, in which serious and grave charges were made

against the Matron She has answered them, and no reparation has yet been demanded.

An account of the above has been brought into the Nursing Record of October 14th. I draw back from quoting the scandalous and libellous charges made both against the Hospital Committee and the Matron; but as a Governor, a member of the Board of Management, and Chaplain, I have written as follows to the
