NURSING IN THE NAVY.

In view of the statement that Inspector-General Henry C. Woods, M.D., M.V.O., K.H.P. (retired), late of the Royal Yacht, who was last July appointed to H.M.S. "President" for service at the Admiralty, has been engaged in preparing a scheme for an increase of the nursing staff in H.M.'s ships and naval hospitals in time of war or of national emergency, and that a reserve of naval nurses, male and female, is to be established, it was decided to forward to the Earl of Selborne, First Lord of the Admiralty, a copy of the Memorandum presented by a Deputation from the Matrons' Council to the Admiralty in 1900.

## THE MIDWIVES' BILL.

Letters from Mr. Heywood Johnstone, M.P., and Mr. Colin Campbeil, M.R.C.S., in reference to the Midwives' Bill, were then read and discussed.

The Hon. Secretary reported that, as directed, she had sent the Resolution passed at the last meeting, dealing with the defenceless position in which it was proposed to place Midwives by Mr. Heywood Johnstone's Midwives' Bill, to Societies interested, and that she had received acknowledgements from the General Medical Council, the National Union of Women Workers of Great Britain and Ireland, the Women's Local Government Society, the Lady Balfour of Burleigh (President), and the Secretary of the Association for Promoting the Compulsory Registra-
