1. Mild aching pains in the limbs and in the loins, rise of temperature of about 103°, closely resembling an ordinary fever resulting from exposure and yielding to mild diaphoretics with a stiff dose of sodium salicylas. No eruption.

2. Excruciating pain in the joints of both upper and lower limbs of one side only. Temperature rises to 105?, lasts, fluctuating, three to five days and yields. Hot fomentation relieves pain (I suffered from this), with or without eruption.

3. All the joints are affected. Pain unbearable; patient helpless, screwed down to bed. Temperature very high; sometimes becomes hyperpyretic; death might follow if temperature be not promptly brought down; generally without eruption.

4. Pain not of a virulent type. Temperature very high, or moderately so. On the second, third, even on the fourth day eruption occurs, in character resembling roseola, or erythema, lasts for two to many days.

In treating the case, purgatives should be studiously avoided, as the movement of the limbs brought on by their action would aggravate the pains and bring on positive evil. Sodium salicylas combined with caffein citras and phenacetin in judicious doses did immense good.
