walls permit one to make a canopy or simulate the three, two, or one-walled shack.

A large amount of fresh air is provided for when the tent is closed tight, as it usually is in winter, by means of the rigid frame around the floor and through numerous vents in the roof On a separate system of poles and guy ropes working a 1-ft. air space and forming a protection at once against heat and storms, is a fly which corresponds in size to the dimensions of the next larger tent of the ordinary

catalogues. 10

: A tent of any size may be used. It is best to advocate a size adapted for one person only. The 10 ft. by 12 ft. is preferable, as it permits of a stove in cold weather. The stove recommended is the ordinary air-tight, sheet-iron heater of the smallest size. The double system of poles is adhered to because of simplicity and familiarity. They are also portable. To strengthen the fly, guy ropes may be run to the tip of the uprights. In the cross-section is shown a device to control the areas of intake by means of boards which slide over the slide between the floor edge and frame. This is not essential, and I would not advocate its use except in the hands of an intelligent patient. The walls of the tent are fastened to the board frame by means of hooks which catch the The gromets are cut at short ingromets. The hooks, which are short, are screwed into the board frame. By turning the hooks down or up one can safely attach or detach the tent walls.

Another device suggested by my tent maker is the use of hollow iron tubing (gas pipe) looped into the lower border of the walls; the tubings to meet at the four corners and bolt together and be fastened to the frame at these points by means of a hook or with a stake. The iron tubing makes an excellent roller for the respective walls. To protect from mosquitoes and insects the intake and vents are covered with mosquito netting. Wire netting is run from the frame up to the eaves. The entrances are draped with netting. The tent is not patented, and I hope any dealer will be able to reproduce it from the descriptions and

There are many modifications which suggest themselves. I have restrained myself for the sake of simplicity and cost. These tents, as described, not including the floor, made of 8-oz army duck, cost in the Minneapolis market, the seven by nine, 20 dols.; the ten by twelve, 22.50 dols.
