

Appointments.

SUPERINTENDENT OF NURSES' HOME.

Miss Beatrice Cutler has been appointed Superintendent of the Nurses' Home at St. Bartholomew's Hospital. She was trained at the hospital from 1885 to 1888, and certificated. From 1888 to 1892 she was Sister at the Kasr-el-Aini Hospital, Cairo; was promoted to be Superintendent of the Medical School for Girls, a position she held until 1898, when she was appointed Matron of the Victoria Home Hospital at Cairo, where she worked for three years. After thirteen years arduous work at Cairo Miss Cutler was selected as Matron to the Much Wenlock Hospital, a position she now resigns to return to her Alma Mater, where no doubt her record of first-class work will be maintained.

MATRONS.

Miss F. Neville has been appointed Matron of the West London Hospital, Hammersmith. She was trained and certificated at St. Bartholomew's Hospital, working in connection with that institution from May, 1895, to November, 1900, when she was appointed Assistant Matron at the West London Hospital. She is a member of the League of St. Bartholomew's Hospital Nurses.

Miss A. Nellie Eastman has been appointed Matron of the Horton Asylum, under the London County Council. She was trained at the Infirmary, Dulwich, and has held the positions of Assistant Matron at Horton Asylum and of Matron at the Epileptic Colony, Ewell.

Miss Dean has been appointed Nurse-Matron at the Joint Hospital, Stone. She was trained at the Royal Infirmary, Manchester, and has worked in connection with the North Staffordshire Nursing Institution, and as district nurse at Trentham.

Miss Lena Jordan has been appointed Matron at the Charterhouse, Hull. She was trained at the Infirmary, Kidderminster, and has had experience in private nursing.

Miss Marion Sarell has been appointed Nurse-Matron at the Iver Langley and Durham Cottage Hospital. She was trained at University College Hospital, London.

Miss Isabella Martin has been appointed Nurse-Matron at the Cottage Hospital, Fife. Miss Martin has had a varied nursing experience, and at present holds an appointment at the County Hospital, Ayr.

Miss Ida Campbell has been appointed Matron of the hospital at Soulima, which belongs to the Danube Commission. She was trained at St. Bartholomew's Hospital, and is a member of its Nurses' League. Hitherto the hospital has been worked by men for men, but now it is proposed to admit women also. Recently a very progressive Italian surgeon has been appointed to the hospital, whose influence has been in favour of the new arrangements.

ASSISTANT MATRON.

Miss J. W. Campbell has been appointed Assistant Matron at the City Hospital, Park Hill, Liverpool. She was trained at the Belvedere Hospital, Glasgow, and has held the position of Charge Nurse and Housekeeper at the City Hospital, Park Hill, Liverpool.

SISTER IN CHARGE.

Miss Ada Williamson has been appointed Charge Sister at the Union Infirmary, Hope, near Eccles. She was trained at Crumpsall Infirmary, and has held the positions of Night Sister at the Homoeopathic Hospital, Birmingham; Sister at the City Hospital, Sheffield; and Sister at the Infirmary, Crumpsall.

SISTER.

Mrs. Isabella Fowler has been appointed Sister at the hospital, Soulima. She was trained at St. Bartholomew's Hospital, and is a member of its Nurses' League.

CHARGE NURSE.

Miss F. A. Webber has been appointed Charge Nurse at the Grove Hospital, Tooting. She was trained at the Hackney Union Infirmary, and has held the position of Charge Nurse at the Brook Hospital, Shooter's Hill, and of Ward Sister at St. Leonard's Infirmary, Shoreditch.

Resignations.

Miss Morgan, Lady Superintendent of Addenbrooke's Hospital, Cambridge, is resigning that appointment. She succeeded Miss Cureton in 1901. The hospital contains 160 beds, and a new curriculum of training for nurses has this year been adopted.

Miss A. A. Gwyn has resigned the post of Matron at the Royal Hants County Hospital, Winchester. She was appointed to her position in 1900. The hospital contains 108 beds. We believe the organisation of the nursing school has been improved of late years, but this hospital was for many years a great offender in that probationers were sent out private nursing to earn money for the institution. Naturally we find the signature of the late Chairman amongst those in opposition to State Registration of Nurses.

Miss Dorothea Oldham, representative of the Royal British Nurses' Association on the Central Midwives' Board, is resigning the appointment, although, as her resignation has been tendered to the Association and not to the Board of which she is a member, the appointment is not yet actually vacant. The present opportunity is a good one for securing on the Board the assistance of a lady who holds the position of past or present Matron of a Maternity Hospital. At present the Board has no such member. Miss A. M. Fox, Matron of the City of London Lying-in Hospital, E.C., would be an excellent representative for the R.B.N.A. if she would act.
