STATE REGISTRATION OF NURSES.

The Hon. Secretary reported that in accordance with the directions of the last Council Meeting she had addressed the following letter to two ladies who had signed the Anti-Registration Manifesto of the Central Hospital Council for London, while members of the Matrons' Council, one of the principal objects of which is "To bring about a uniform system of Education, Examination, Certification, and State Registration for Nurses in British Hospitals."

DEAR MADAM, -At the recent meeting of the Matrons' Council attention was drawn to the fact that your signature is appended to a document recently issued opposing the principle of State Registration for Nurses. This appeared to the Council incompatible with your position as a member of a Society pledged to support this reform, and I was therefore desired to send you a copy of the By-Laws (object two, above quoted, being marked), together with the form signed by all applicants for membership of the Council. (I, the undersigned, apply to be elected a member of the Matrons' Council. In the event of my being so elected in consideration thereof, I promise and agree to conform to, and be bound by, the By-Laws and Regulations of the Council.) The Council would be obliged by information from you as to your attitude on this matter —i.e., as to whether you contemplate keeping your name on the Anti-Registration Manifesto or resigning your membership of this Society.
