The Society for the State Registration of Murses.

At the meeting of the Executive Committee of the above Society, held at the offices, 431, Oxford Street, on Wednesday, May 3rd, Miss Isla Stewart in the chair, the Hon. Secretary presented a report, in which she stated that the Bill promoted by the Society was introduced into the House of Commons by Mr. Munro Ferguson on February 23rd, and had been down for a second reading on several occasions, but owing to the business of the House had not been reached. The Hon. Secretary also made a full report of the measures taken by the Society to protest against the incorporation by the Board of Trade of the "Society for Promoting the Higher Education and Training of Nurses," with the result that an inquiry was to be held on the matter, to which the Society had been invited to send representatives.

LETTERS.

1. Amongst others, letters were received from several important institutions notifying that they would oppose the granting of the Licence of the Board of Trade to the above-mentioned Society.

2. From Miss Mollett, President of the Royal South Hants Nurses' League, enclosing a copy of

the following resolution:

The Executive Committee of the Royal South Hants Nurses' League desires to express its disapproval of the scheme which has been presented to the Board of Trade, by which laymen seek to obtain power to exercise educational and disciplinary control over the nursing profession, and to place on record its unabated confidence in the efforts of the Society for the State Registration of Nurses to compass an efficient professional control through the Bill for the State Registration of Nurses now before Parliament.

SUPPORTERS OF STATE REGISTRATION.

It was reported that upwards of 1,800 influential persons had signed a statement in favour of the principle of State Registration who were not members of the Society, amongst them nearly 700 registered medical practitioners, resident all over the country, 113 Matrons, and several hundred Assistant Matrons, Sisters, and Nurses, and the Hon. Secretary was requested to hand in the names to the Select Committee on Nursing of the House of Commons.

FINANCE.

It was reported that the President, Miss Louisa Stevenson, had most generously given another £10. to help the great expenditure of the Society in preparing evidence for the Select Committee and the

Board of Trade, and that donations to the amount of £39 7s. had altogether been received from twenty-eight members of the Society for the same purpose.

THE ANNUAL MEETING.

It was arranged that the Annual Meeting should be held on May 26th, at 11, Chandos Street (Medical Society's Rooms), Cavendish Square, at 3 p.m., to receive the Annual Report and elect the Executive Committee, and that the Agenda should be printed in the British Journal of Nursing.
