DAY NURSERY FOR THE CHILDREN OF WORKING MOTHERS.

To the Editor of the "British Journal of Nursing."

MADAM, -May we appeal through your columns to all lovers of children to help the Day Nursery for the

Infants of Working Mothers?

The need for the institute cannot be exaggerated. To-day the working mother finds herself in a cruel position—either she must abandon her necessary efforts to earn bread for her little ones, or she must remain under the gravest apprehension that while she is absent from home they will not receive proper care. Frequently the hands into which she must entrust them are inexperienced or careless, or worse. The children get had food, and are without that constant attention so necessary to the very young. Often they sustain physical injuries felt throughout their lives. What their immediate sufferings are those who have visited poor districts may see for themselves; the results in child mortality and the lives of the rachitic and unhealthy who survive, medical experts have pointed out again and again.

A remedy for this state of things will be provided by A remedy for this state of things will be provided by the establishment of Model Day Nurseries in some of the poorer districts of London. There competent nurses will attend to the children; there will be thorough and constant medical supervision, there bathing, feeding, clothing, and all the branches of child-rearing will be carried out in the best ways known.

Our Committee consists of those having a practical first-hand acquaintance with the lives of the poor, and its members have, either as guardians, social reformers, or in other capacities, been brought into close touch with the lives of the workers in our great

Every care will be taken to ensure the strictly economical conduct of the Nurseries. We have already received many encouraging expressions of good will and kind gifts, but to establish the institution on a firm having record a large and the conduction. tion on a firm basis we need a large accession of funds.
