#### A STANDARD FOR MATRONS.

To the Editor of the "British Journal of Nursing."

DEAR MADAM,-It seems high time that hospital Committees had some standard other than looks and frocks to go by in appointing Matrons, as it is most unfair on a school and those who train in it, to be placed under women who have never gone through the mill. Is it presumable that if a woman had ever done nine months' night duty on end, she would tolerate such a system as long term night duty in the hospital over which presided? I don't think so. Also, if she she had been taught cooking many a nursing staff would stand the strain of hospital work better than they do to-day, as she could then point out what was wrong in the commissariat, instead of being de-pendent on the knowledge of others. It is very disheartening to equip oneself for a Matron's post to the best of one's ability, and then be passed over by Committees of men, who know very little of what goes to train a Matron, for others far less experienced. The East End women wanted the Premier to go and live down East a bit, to realise how the poor live. I should like hospital Chairmen to be put on night duty for six months or so at a time, and see if it agreed with their health, or do a year's "Lady Pro" and then say if they felt justified in accepting a certificate as a trained nurse. We must have a standard for Matrons if we are to progress. Qualities are required in them that every trained nurse does not necessarily possess. "A PERMANENT NIGHT NURSE."

[We wonder why our correspondent is a permanent night nurse. Surely the most obsolete Committee could be influenced by the Matron to abolish such a system.—ED.]
