The annual meeting of the Committee of the Queen's Commemoration Fund was held on Tuesday at 120, Victoria Street. The Duke of Portland presided. The report and accounts for 1905 were adopted showing that during the past year £2,410 had been collected in annual subscriptions and donations for the benefit of Queen

Victoria's Jubilee Institute for Nurses.

All active steps taken to minimise the spread of tuberculosis are to be commended, and an important movement regarding the treatment of tuberculosis is on foot at the Brompton Consumption Hospital. Under the advice of the medical staff, a joint sub-committee of the committee of management and of the medical committee has been appointed, and is now about to begin its sittings, to consider the possibility of enlarging the scope of the hospital's operations so as to deal more effectually with the disease from the national rather than the individual point of view. The joint sub-committee will receive the assistance of Dr. Newsholme. the medical officer of health for Brighton, nominated by the Royal Sanitary Institute, and will consider the feasibility of reaching the sources of infection in the homes of the poor. The object of the committee will be the efficient treatment, not only of any patient who may apply for relief, but also of any member of his family who may be found on further inquiry to be suffering from the disease. In this way, and by active co-operation with medical officers of health, each focus of infection will receive adequate attention, and in time much should be done to lessen the incidence of the disease.

District Nurses should be specially invited to co-operate in this good work. They have unique opportunities for coming in contact with phthisical patients in the early stages.
