The Society for the State Regis= tration of Trained Murses.

A meeting of the Executive Committee was held at the Offices, 431, Oxford Street, on Saturday the 29th inst. Miss Isla Stewart, Vice-President, in the Chair.

HON. SECRETARY'S REPORT.

The Minutes having been read and confirmed, the Hon. Secretary, Mrs. Bedford Fenwick, submitted the following Report :-

I beg to report that on July 27th, at a meeting held in the Caxton Hall, Westminster, the Representative Meeting of the British Medical Association discussed the question of State Registration of Trained Nurses, and passed by 90 votes to 3 the following resolution :-

"That this meeting approves of the recommendation of the Parliamentary Select Committee that there should be State Registration of Nurses, and is of opinion that, on any central Council or Board appointed, the medical profession and the nursing profession should be adequately and directly represented.'

The question had previously been referred to the Branches, and the delegates instructed how to vote, so that the medical support given to the principle of State Registration was emphatic.

The fact that the meeting supported the vital principle of Direct and Adequate Representation of the nurses on their own Governing Body was of the highest importance and most gratifying to the members of this Society who, in an official communication, specially asked for the consideration of the delegates on this most important point.

A letter has been received from the President, who, although unable to be present, takes the deepest interest in the work of the Society-enclosing two anonymous donations of £10 each. Most welcome gifts at this particular time, when the expensive work of organising a Petition to the Prime Minister is to be undertaken.

Miss Mary Burr has been good enough to accede to the request that she should act as Hon. Secretary in connection with the Petition.

It is with very deep regret that I have to report the sudden death of Miss Georgina Kinninmont, Matron of the West of England Eye Infirmary, at Exeter, by which the profession at large loses a most devoted member, and the Registration Cause an ardent supporter.

RESOLUTIONS.

The Report having been adopted, a vote of thanks was passed to the anonymous benefactors to be forwarded to them through the President, and the following resolution, proposed by Mrs. Fenwick and seconded by Miss E. M. Roberts, was carried unanimously :---

" That the Executive Committee of the Society for

the State Registration of Trained Nurses have learned with the deepest regret of the death of Miss Georgina Kinninmont, Matron of West of England Eye Infirmary, Exeter, and a member of this Society, and desire to place on record their sense of the loss sustained by the Society in the death of a most warm supporter and fearless advocate of the cause of State Registration."
