Sarah Skitt, 1759. Charges: Not taking appliances and antiseptics. Not declining to attend alone in a case of raised temperature and foul discharges. Uncleanliness. *Decision*: Struck off the Roll, and certificate cancelled.

Thurza Smith, 1683. Charges: Not declining to attend alone in a case of retained placenta, and of hæmorrhage lasting for two hours. Of going to another case from one of puerperal fever without disinfecting. Not carrying appliances or antiseptics. Not keeping a register of cases. *Decision*: Struck off the Roll, and certificate cancelled.

May 17th.

The cases considered on May 17th were:

Emma Page, 3874. Charges: Uncleanliness, not possessing antiseptics and appliances, not keeping a register of cases. The vicar of the parish wrote to say that Mrs. Page had called upon him with respect to help as to getting the appliances. He sent her to the secretary of the local nursing association. It was stated in evidence that this lady told Mrs. Page it was "all red tape and Tommy rot." A letter read from the lady said that she had since this interview repeatedly urged Mrs. Page to get the appliances. *Decision*: Name removed and certificate cancelled.

Mary Ann Smith, 12110. Charges: Negligence and misconduct. Mrs. Smith appeared, and was defended by her solicitor. Two of the original charges preferred against her were not proceeded with. *Decision*: Cautioned.

Sarah Scott, 9687. Charges: Negligence in not declining to attend alone a patient with a high temperature. Not taking the temperature. Failure to notify the Local Supervising Authority that a doctor had been summoned. Uncleanliness; not possessing appliances and antiseptics, or keeping a register of cases. Mrs. Scott, who appeared, said she should regard 55 degrees as a very high temperature. She was humble, but never dirty. *Decision*: Removed from the Roll, and certificate cancelled.

Mary Elliott, 20365. Charge: Intoxication while in attendance on a case. *Decision*: Removed from the Roll, and certificate cancelled.

Mary Dunn, 13645. Charge: Convicted of keeping a disorderly house, and sentenced at Sunderland Police Court to six weeks' imprisonment. *Decision*: Removed from the Roll, and certificate cancelled.

Charlotte Hales, 20533. Charges: Uncleanliness; not possessing appliances and antiseptics; not keeping a register of cases. *Decision*: Removed from the Roll, and certificate cancelled.

Emma Applegate, 20776. Charges: Making no attempt to resuscitate a child apparently dying. Not wearing a washable dress. Not possessing appliances or antiseptics. Not keeping a register of cases. *Decision*: Removed from the Roll, and certificate cancelled.

Mary Broxon, 5903. Charges: Not declining to attend alone a patient who had had a rigor.

Not notifying the local supervising authority that a doctor had been sent for. Not possessing appliances and antiseptics. Not keeping a register of cases. *Decision*: Removed from the Roll, and certificate cancelled.

Grace Lillicrap, 19919, and *E. J. Brennand*, 21152. Charges: Persistently refusing to provide themselves with appliances or antiseptics, or to keep a register of cases. *Decision*: G. Lillicrap, who was 77 years of age, and had been in practice 40 years, was allowed to resign. E. Brennand was removed from the Roll.

Mary Upton, 16701. Charges: Negligence and misconduct in attending a case of suppurating cancerous breast simultaneously with a confinement case, and in another instance of attending a woman in labour without disinfecting. *Decision*: To be cautioned, and a report asked for in three months' time from the Local Supervising Authority.

Catherine J. Waugh, 13312. Charges: Not declining to attend alone an infant with an inflamed navel, and advising against a doctor being summoned. *Decision*: Censured, and a report asked for in three months' time from the Local Supervising Authority.

Mary Lewin, 7044. Charges: Negligence in not taking the requisite appliances and disinfectants to a case. Of making unnecessary vaginal examinations. Of not declining to attend alone in a case of puerperal fever. Uncleanliness. Not keeping a register of cases. *Decision*: Removed from the Roll, and certificate cancelled.

Martha Ann Lawrance, 17635. Charges: Negligence and misconduct. Failure to disinfect her hands and forearms. Extracting, not attempting to express the placenta. Only visiting the patient once after a labour. Uncleanliness. Failure to keep a register of cases. *Decision*: Removed from the Roll, and certificate cancelled.

Ellen Lang, 9388. Charges: Negligence in not advising medical assistance should be sent for in a case of ruptured perineum. Not taking the necessary appliances and antiseptics to a case. Failure to wash the patient and attend to her cleanliness and comfort. *Decision*: Struck off the Roll, and certificate cancelled.

Hannah Rhodes, 5377. Charges: Negligence and misconduct. *Decision*: Cautioned.

Louisa Wood, 7887. Charges: Advertising her willingness to treat disease. *Decision*: Severely censured.

Bridget Duffy, 5560. Charges: Failure to notify the Local Supervising Authority of the death of a child, and of the birth of a still-born child. Of being habitually unclean, and living in a dirty and verminous house. Not possessing appliances, antiseptics, or a register of cases. *Decision*: Removed from the Roll, and certificate cancelled.

Ellen Pomfret, 21224. Charges: Not declining to attend alone in a case of abortion. Not possessing the necessary appliances and antiseptics, or keeping a register of cases. *Decision*: Severely censured. Report from Local Supervising Authority asked for in three months' time.
