within the means of suffering humanity-rich and poor. The lowering of district nursing standards during the past decade—by county nursing associations—cannot be defended. Partially-trained Partially-trained nurses are supplied to the poor because they are cheap. Let us be frank in dealing with this ques-The committees which control them are people of leisure, usually with no expert know-ledge, the majority of the women on which have never been compelled to earn a penny in their lives. In consequence the salaries paid to Cottage Nurses are scandalously low, and to systematically create a class of inefficiently trained women workers, who are paid scarcely a living wage, from which they cannot possibly provide for sickness and old age, is economically unsound, and, in our opinion, indefensible.—ED.]
