THE SOCIETY FOR STATE REGISTRATION OF TRAINED NURSES.—MAY 2ND.

The Annual Meeting of the Society for the State Registration of Trained Nurses will be held at the Medical Society's Rooms, 11, Chandos Street, Cavendish Square, London, W., on Saturday, May 2nd, at 4.30 p.m. Miss Isla Stewart will preside. *Agenda*.

#### Resolutions. I.

"That the members of the Society for the State Registration of Trained Nurses in Annual Meeting assembled desire to express emphatic and determined opposition to the Bill "To Provide for the Establishment of an Official Directory of Nurses" recently introduced into the House of Lords, for the tollowing reasons:

(a) It has been privately promoted by the Central Hospital Council for London without consultation with the class for whom it is proposed to legislate.

(b) It affords no guarantee of a nurse's efficiency to the public, as no minimum standard of professional knowledge is required.

(c) It makes no provision for a Central Governing Body upon which trained nurses are represented, and which would maintain standards of education, and discipline, as required in the Bill promoted by this Society, and now before the House of Commons.

For these reasons this Society, consisting of over 2,000 Matrons and nurses, urgently petitions the members of the House of Lords to reject the Official Directory of Nurses Bill on its second reading.

#### IT

"This Meeting desires that a copy of the foregoing Resolution be sent to his Majesty's Ministers, to every member of the House of Lords, and that the Lord President of the Council be asked to receive a Deputation to convey to him the Resolution.

#### III.

"That the Executive Committee of the National Union of Women Workers be requested to place the following Resolution on the Agenda of the Annual Meeting of the National Council of Women of Great Britain and Ireland, to be held at Aberdeen in October next.

"That this National Council considers that it is desirable both in the interests of the professional status of trained nurses, and of the public who use their services, that provision should be made for their registration by the State; such registration to be under the supervision of a Central Board upon which nurses shall have direct and adequate representation.
