Registration, and all that it means for the uplifting of nursing, and the protection of the defenceless sick. The "London" is a large place, . and the whole staff very busily engaged. We read but little there, and took no interest in nursing beyond our own wards, and until I came out into the world and realised the present unjust conditions, the lack of standards, and the constant ten-dency to depreciation all over the country in private and district nursing, I never thought about the matter. For years these anti-registra-tion "Letters" have been issued from the inner sanctum of the nursing department of the London Hospital, and are calculated to mislead. Indeed, the fact that Mr. Holland had helped to draft the Directory Bill was all apparently that the nurses trained at the London need to know. never submitted for their consideration, and if it had been I doubt if they could have grasped its insidious and demoralising effect once it had be-•come law.

The truth is that by acquiescing in the anti-registration "obsession" of the Matron and the "Chairman of the London Hospital, "Londoners" are failing in their duty to the profession at large. A LATE LONDON HOSPITAL SISTER.

#### TO SAVE THE BIRDS.

To the Editor of the "British Journal of Nursing."

DEAR MADAM,-It is sincerely to be hoped that the Select Committee, to which Lord Avebury's "Importation of Plumage Prohibition Bill" has been referred by the House of Lords, will realise the need of prompt as well as stringent legislation if whole species of beautiful birds are to be saved from destruction.

It has been suggested that foreign Governments should first be consulted. If other countries are willing to assist us by taking joint action, so much the better; but such official communications are apt to be dilatory, and meantime the insensate slaughter will go on. There is no reason why this country should not at once legislate for herself, and thus set a much-needed example which is likely to be followed elsewhere.

For many years the Humanitarian League has been calling attention to this matter, and has long had in circulation a Bill similar in principle to that which has recently been read a second time in the Upper House.
