THE PASSING BELL.

The death at Gort Convent, co. Galway, of Mother Superior Aloysius Doyle, at 94 years of age, removes the survivor of the sixteen nuns of the Order of Mercy who left Ireland in December, 1854, to assist Miss Florence Nightingale in nursing the soldiers in the Crimea. She was summoned to Windsor by Queen Victoria in 1897 to be decorated, but was too old to undertake the journey, so the Royal Red Cross was sent to her. Her sister, aged 90, a nun in the same convent, still survives.

We regret to announce the death, after a short illness, at St. Helena, of Nursing Sister Ormerod, who, for the last two years, has been on the staff of the civil hospital in the island. Miss Ormerod was trained at the Hospital, Newark, and at Newcastle-on-Tyne, and she also was on the staff of H.R.H. Princess Christian's Nursing Home at Windsor. She served in South African Hospitals during the recent war, for three years, and received the King's medal for her services. Much sympathy is felt with Miss Ormerod's father, Mr. Richard Ormerod, of Kirkbride, Cumberland, who has already lost both of his other children—one son, a missionary in East Africa, of black-water fever, and the other who was drowned on the eve of going abroad.

We regret to announce the death from enteric, on September 5th, at St. Stephen's Hospital, Delhi, of Miss Agatha M. Allen, trained at Guy's Hospital, London. Miss Allen went out about three years ago, under the S.P.G. Mission, to take charge of the nursing at St. Elizabeth's Hospital, Karnal. She was an active member of the Association of Nursing Superintendents of India, and for the past two years served on the Executive Committee.
