A MATERNITY WARD AT MIDDLESEX HOSPITAL.

The London Hospital and Guy's Hospital have already their Maternity Wards, and now Middlesex Hospital must be added to the list of those which provide this special training. On November 1st it is hoped this ward, containing ten beds for maternity cases, will be opened, the Sister and Staff Nurse both being certified midwives. The hospital has already an externe department in connection with which a certified midwife is employed. The opening of the maternity ward is a return to the practice of former days.

THE NATIONAL MATERNITY HOSPITAL, DUBLIN.

The Very Reverend Canon Fricker, P.P., preaching the Annual Charity Sermon for the above institution, said that 1,000 patients were received into the hospital during the past year, and 1,400 were attended in their own homes. That meant that, whilst his hearers were lying asleep in their comfortable homes, nurses and doctors from Holles Street were out on duty, regardless of the harshness of the weather or the discomforts of the hour, the only solitary consideration being the necessity of the call.

THE COOMBE HOSPITAL, DUBLIN.

The Rathbone Board of Guardians have recently been in correspondence with the authorities of the Coombe Hospital, Dublin, respecting the boarding out of a nurse child which subsequently died. The Guardians have now passed a resolution exonerating the hospital from all blame in the matter.

THE SUFFOCATION OF INFANTS.

The House of Commons on Monday proceeded with the consideration of the Children's Bill on its Report stage, as amended by the Standing Committee. Mr. Samuel, who has charge of the Bill, moved the insertion of the following new clause: "Where it is proved that the death of an infant under three years of age was caused by suffocation (not being suffocation caused by disease or the presence of any foreign body in the throat or air-passages of the infant) whilst the infant was in bed with some other person over sixteen years of age, and that that other person was at the time of going to bed under the influence of drink, that other person shall be deemed to have neglected the infant in a manner likely to cause injury to its health within the meaning of this part of the Act." The clause was added to the Bill.
