

## Appointments.

### LADY SUPERINTENDENT.

#### The Mothers' and Babies' Welcome, Nottingham.

—Miss Annie Mackenzie has been appointed Lady Superintendent of the Mothers' and Babies' Welcome at Nottingham. She has received Sanitary Training at the Royal Sanitary Institute, London, and in midwifery in connection with the Birmingham Lying-in Charity. She has worked as a Health Visitor in connection with the Birmingham Health Committee, and as Inspector of Midwives under the Warwickshire County Council.
