#### **EXAMINATIONS**

The report of Dr. John Fawcett, Physician to Guy's Hosp., on the examination of the probationer nurses at the Portsmouth Infirmary, which was submitted by the Infirmary Committee to the Guardians at a recent meeting exemplifies the value of an independent examination, and of the criticism of an examiner. Dr. Fawcett expressed his satisfaction with the second and third year nurses, the examinations showing that the standard of teaching had been well maintained throughout the year with very good results. His report, in part, is as follows:

Third year.—Two nurses from among those in the third year failed, while 10 were successful; Nurses Gibbs and Coggan passed a "very good" examination; Nurses Honeywood, K. Willens, B. A. B. Smith, A. Delahay, and L. Vinell, a "good" examination; and Nurses K. A. Houghton, S. Taylor, and E. L. Hewett a "satisfactory" examination.

Second year.—From amongst the second year nurses eight were successful, and one failed; Nurse K. Austen passed a "very good" examination; Nurses Gill, R. Smith, Killick, and Heard a "good" examination; and Nurses Corney, Faithwaite, and Covington, were "satisfactory.

First year.—Of the first year nurses I am unable to speak in such high terms as in past years, as the result of the examination was by no means satisfactory. The answers to the questions set in the papers were, in many cases, less complete than usual, and badly expressed. The result of the viva voce examination was, on the whole, satisfactory. A study of the papers appears to me to point to the conclusion that the standard of general education attained by some of the candidates, previous to the commencement of their training, was considerably below that of former years.

Commenting on the report the Chairman, Mr. E. Hall, said that the aim and object of the Committee in the future should be to see that the scholastic part of the nurses' education should be gone into first, and that the training should follow. This is a very satisfactory outcome.

### WEDDING BELLS.

Sister Sarah O'Neill, who has been for 15 years nurse in Cork Street Fever Hospital, Dublin, nas resigned her post on account of her approaching marriage. Amongst the gifts she received were a cheque from the Committee, dinner and tea service from members of the Nursing Staff, household linen from the Matron, and from a grateful patient a silver tea service and biscuit box.
