## WORKHOUSE NURSING ASSOCIATION.

Her Royal Highness Princess Christian presided over a general meeting of the Workhouse Nursing Association, which was held at 33, Hill Street, on March 10th. Among others present were the Marquis of Salisbury (Vice-President), the Lady Wantage (Hon. Vice-President), the Lord Henry Bentinck (Chairman of the Executive Committee), Mr. H. Dixon Kimber (Hon. Treasurer), and Miss Gill (Secretary).

The Association having been recently reorganised, the objects of work drawn up when the Association was founded in 1879 have been revised by the Executive Committee, and they include the following points which were adopted by the general meeting :

 To enlist public interest in the whole question of nursing in Workhouse Infirmaries.
To promote a high standard of nursing in Workhouse Infirmaries and sick wards; and to advocate the appointment of trained

nurses therein. 3. To obtain information on all points con-

nected with nursing in Workhouse Infirmaries. 4. To promote and to assist in any altera-

tions of the law applicable to Workhouse nursing that may from time to time seem desirable.

The Committee has been actively engaged in considering the new L.G.B. Orders, and there was evidence of strong feeling at the meeting that these Orders are still most unsatisfactory as regards the nursing in rural workhouse sick wards; and that pressure must be brought to bear upon the L.G.B. to consider means to solve the question of the proper care of the sick poor in rural districts. The Chairman of the Executive Committee (Lord Henry Bentinck) pointed out that it must be realised that persons in small workhouse sick wards can be as ill as those in a large institution; and require skilled care, whatever the number may be. The desire of the Association is to see a trained nurse appointed in every institution where there are any sick, however few the number. Miss Gibson considered that the formation of a Poor Law Nursing Service was urgently necessary, by which nurses could be attracted to and retained for Poor Law nursing ; but she felt that before the formation of such a Service, it would be necessary for the Local Government Board to appoint a strong and representative Advisory Committee to consider carefully the best scheme to carry out such an undertaking.

Reference was made to the great loss the Association had sustained by the retirement through ill-health of Miss Wilson (the Hon. Treasurer); and H.R.H. Princess Christian moved a resolution, which was seconded by Miss James, and carried unanimously, recording the deep sense of the Association's obligation to her for her services to the cause of nursing under the Poor Law.

The Treasurer (Mr. H. Dixon Kimber) made an appeal for funds to carry on the work. He

mentioned that many of the subscribers who had supported the Association in the past had again responded to his appeal; but that new subscribers are needed to maintain a working fund.
