# GENERAL NURSING COUNCIL FOR SCOTLAND.

Proceedings at Meeting held at 18, Melville Street, Edinburgh, on Friday, January 9th, 1925.

The report of the Education and Examination Committee

was approved.

Included in the correspondence dealt with was a letter from the Joint Nursing and Midwives' Council, Northern Ireland, enquiring the Council's reasons for allowing Candidates who have failed in one or more subjects of the Preliminary Examination to sit again for those subjects only in which they had failed in place of the whole Examination. In terms of the recommendation of the Committee, the Council resolved to adhere to their regulation, which they considered was the most usual one in such examinations.

Some additional names were added to the Panel of Examiners and the arrangements were approved for the Preliminary Examination to be held in February.

We are asked by the General Nursing Council for Scotland to emphasise to nurses who have completed their training between November 1st, 1919, and the present time that they should now send in their applications for registration. The period of grace for such nurses expires in Scotland on September 30th next, and the Council fears that, as happened when the period of grace for existing nurses closed, large numbers of applications will arrive too late, the applicants stating that they were not aware of the last date for applying.

We would also remind Intermediate Nurses in England and Wales (i.e., "every person who, not being qualified to obtain admission to the Register as an Existing Nurse, desires to obtain admission thereto before July, 1925, on which date the training and examination rules come into
