GENERAL NURSING COUNCIL FOR ENGLAND AND WALES.

A Meeting of the General Nursing Council for England and Wales was held at 20, Portland Place, W.I, on Friday, December 18th, SIR WILMOT HERRINGHAM, K.C.M.G., Chairman of the Council, presiding.

Minutes.

Arising out of the Minutes, MISS DU SAUTOY asked whether correspondence was not printed on the minutes in order that it might be on record. She was of opinion that this was the usual procedure.

THE CHAIRMAN stated that the Motion was that the correspondence presented at the last meeting (the letter and Resolutions of the Registered Nurses' Parliamentary Council) should lie on the table. That meant that it was not inscribed on the Minutes.

Correspondence,

THE CHAIRMAN reported that a letter had been received from the Royal Sanitary Institute, inviting it to send delegates to a Conference in the Guildhall, London, from July 5th-roth. If any members of the Council were attending they might be willing to represent it. He thought DR. SMEDLEY would probably be going. MRS. EUSTACE HILLS said that she would be attending in connection with the National Society of Day Nurseries.

MISS MUSSON considered that the Council should send a trained nurse. Many questions arose in relation to babies and young children, concerning which they had expert knowledge which was of importance. MISS DU SAUTOY expressed her willingness to represent

the Council.

THE CHAIRMAN said that fI IIS. 6d. would have to be paid for a ticket and report of the proceedings for each member appointed.

The question was raised as to whether the Council had not decided not to send Official Representatives to Public Conferences.

MISS COX DAVIES said she was sure this was so. As the Registrar was apparently unable to give the requisite information on this point, the question of the appointment of delegates was postponed to the next meeting.

Report of the Finance Committee.

The Council approved the payment of Bills and Claims submitted, the sum of \pounds_{100} for stamps, \pounds_{20} for Insurance stamps, and \pounds_{15} for Petty Cash. Also that on the recommendation of the General Purposes Committee eight 5-drawer-section Card Index Cabinets should be purchased

5-drawer-section card index cabinets should be producted at $\pounds 6$ each, and three Cupboards at a cost of $\pounds 11$. It also approved the recommendation of the Finance Committee "that the sum of $\pounds 48$ 16s. 6d. be paid to the Architect, being additional account for supplying extra. plans for Public Authorities, and payment for time and plans for Fublic Authorities, and payment for time and expenses in connection with consultations with these authorities, also the sum of $\pounds 47$ 3s. 6d. being percentage on accounts for fittings and furniture supplied by the Builders, Council Room Table, Blinds, &c." It was agreed for the purpose of adapting the present

Council Room Table, two extra small tables be purchased at a cost of £6 2s. 6d. each.

The Committee reported that the House Committee appointed by Council on February 15th, 1924, was dissolved on November 9th, 1925, and that any matter pertaining to the House will be considered in future by the General Purposes Committee for Recommendation to the Finance-Committee.
