LEGAL MATTERS.

The jury at an inquest at Taunton (as reported in the Taunton Express and Echo), on Louisa Berry, aged fifty-two years, wife of Mr. F. G. Berry, a clerk in the Taunton G.P.O., returned a verdict in accordance with the medical evidence, the foreman adding, "We consider there must have been neglect on someone's part.'

Dr. L. H. C. Birkbeck deposed to operating on deceased at a nursing home in October last to remove a fibroid tumour. Twelve days later she showed signs of internal obstruction from which she partially recovered, but as she did not get well another operation was recommended. This she underwent at the Taunton and Somerset Hospital on February 14th. Witness then found that a large swab or abdominal towel had been left in the abdomen at the first operation, and that this had caused ulceration of the intestine. It seemed likely that the patient would recover, but later there was evidence of serious spread of the ulceration, and a further operation had to be performed. She died, however, the following morning. The third operation disclosed perforation of the small intestine caused by ulceration in four places. The ulceration was due he alleged, to the presence of the swab, which was about r_2 in. by r_4 in. Dr. Winckworth and Dr. Ellis were present at the first operation, Dr. Winckworth being the anæsthetist.

Replying to the Coroner (Col. D. S. Watson), Dr. Birkbeck said the towels or swabs were done up in bundles of six, and at an operation they were counted before and after the wound was closed. It was not the duty of the operating surgeon to count the towels. In this case it was done by the sister or assistant nurse at the nursing home.

Dr. W. B. Winckworth said he had been present at many operations, and had never known the nurses miss. a count. There was always an inquiry at the end of the operation over the number of swabs and towels.

Mr. Francis Gerald Berry, the husband, remarked that he thought it a very serious omission at the nursing home.
