# THE BRITISH COLLEGE OF NURSES.

## REPORT OF THE COUNCIL MEETING.

The Eighty-fourth Meeting of the Council of the British College of Nurses was held at 39, Portland Place, London, W.1, on Saturday, January 20th, 1934. The President, Mrs. Bedford Fenwick, was in the Chair,

Prayers having been read by the Secretary, the Minutes of the last Meeting were confirmed.

#### DEATH OF MISS HELEN LUCY PEARSE,

The President, on rising, reported, with the very deepest regret, the death of Miss Helen L. Pearse, a past Vice-President of the College, which occurred on December 27th. The President spoke warmly of her distinguished work and lovable personality, and felt sure the Council would wish to send an expression of sympathy to her brothers. This was the unanimous wish of the Council.

### BUSINESS ARISING OUT OF THE MINUTES.

Letters received from the following members of the General Nursing Council for England and Wales, acknowledging the vote of thanks sent by the President and Council for the support given by them at the Meeting of the General Nursing Council for England and Wales on November 24th, to the Recommendation of its Education Committee :—

"That the Council re-affirm the decision made by the Council on July 22nd, 1932, viz., 'That the Council is of opinion that it would not be in the interests of the candidates nor of the Profession that the Preliminary Examination should be divided.'"

(b) Miss W. Bowling: Thanks the President for her kind letter. She feels strongly that in supporting the Recommendation of the Education Committee she is supporting what is ultimately the best for the Profession as well as what is the wish of the Profession to-day.

Innes: "I greatly appreciate your letter received this morning from the Council of the British College of Nurses, thanking me for my support at the Meeting of the General Nursing Council for England and Wales against the division of the Preliminary State Examination. I feel very strongly on that point and shall certainly do all I can to support the decision ratified on November 24th. I feel that to divide the Examination would be a serious retrograde step. Thanking you again for your kindness."

(c) It was agreed that the Meeting be held early in March, and that the invitation be extended to all Nurses who signified a wish to be present.
