BIRTHDAY PARTY AND BIRTHDAY GIFTS.

The Birthday gathering on 7th December was as gay as usual and a large number of Members attended to show their goodwill to their Association ; the large drawing rooms begin to seem small in comparison with the guests they have to accommodate on these occasions, but it is always a case of "the more the merrier" at 194, Queen's Gate, and the Club Members are splendid hostesses, ever ready to "forage" among the tea tables for those who are less well acquainted with their Club and its customs.

Mrs. Bedford Fenwick, as Founder of the Association, cut the first piece of the large cake after all the blazing candles had burned down to their sockets and, in reply to a toast from the Members, made a beautiful speech indicating what the nurses of the present day owe to those who built up the Association and took the first bold steps towards the organisation of the profession. THE GENERAL NURSING COUNCIL FOR ENGLAND AND WALES.

The one-hundred and sixty-third meeting of the General Nursing Council for England and Wales was held at the offices of the Council, 20, Portland Place, London, W., on December 14th. The Chairman, Miss E. M. Musson, C.B.E., R.R.C., LL.D., presided.

Correspondence.

The Chairman reported the receipt of a letter ratifying reciprocity between the Graduate Nurses of British Columbia and the General Nursing Council for England and Wales.

The Chairman read the following letter from the British College of Nurses :---

The British College of Nurses, 39, Portland Place,

London, W.1.

December 1st, 1934.

To the Chairman and Members of the General Nursing Council for England and Wales.

MADAM,-At a recent meeting of the Council of the British College of Nurses the letter sent in reply to the Resolution adopted by my Council on September 22nd, inviting the General Nursing Council for England and Wales to consider the advisability of giving publicity to the results of the Final Examina-tions in the general press was read, and I was directed to convey

- on October 26th, that a communication from a body of Registered Nurses should be "laid upon the table," is
 - not only discourteous but inexpedient.
 2. That my Council considers the expenditure of £300, if necessary, to give publicity to the results of the Final State Examinations would be justified taking into consideration the fact that Registered Nurses provide the whole cost, upwards of £20,000 a year expended by the Council in conducting Examinations.

My Council hope, therefore, that the General Nursing Council for England and Wales will, in the future, adopt a more sympathetic conduct of business in dealing with communications received from Registered Nurses, and also that it will take into consideration the advisability of direct expenditure in support of the status of the members of the Nursing profession, thus following the established custom of a large number of educational bodies, including the Royal College of Physicians, the Royal College of Surgeons, the Council of Legal Education, the Law Society, the Royal College of Music, the various Universities, Colleges and Public Schools Colleges and Public Schools.

Finance.

On the recommendation of the Finance Committee, bills and claims submitted for payment were approved, and the sum of $\pounds 25$ for Insurance Stamps and $\pounds 10$ for petty cash, were allowed.

Registration.

Applications for approval for Registration on December 14th, 1934, were :- General Register, by reciprocity, 15; Supplementary Part of the Register, by recipitority, it's examination, 15, by reciprocity, 1; Total 31. It was agreed that 43 Nurses who had hitherto failed to

pay their Retention Fee, and now wished their names reincluded in the Register, should be re-included.

Education and Examination.

On the recommendation of the Education and Examination Committee, it was agreed that the Scheme of Affiliation between the Warwickshire King Edward VII. Memorial
