No system of philosophy makes much appeal to me if it is divorced from the consideration of practical consequences."

"Our senses—they are our most valuable Again: servants. So valuable that Nature protects most of them instinctively. If a light be too sudden or too glaring, we blink, and so save from harm the delicate curtain of the retina. If the motor car threatens to crash, we shrink, to render as small as possible the field of possible damage to our skin and all that it protects. But there is an exception: the human ear cannot be closed by any reflex, safety mechanism. It is as though Nature never dreamt that we should be such fools as to produce machines so fast that we took no pains to control the noise they make. And so, unable as we are to shut out the din, we must perforce put a mute on it. There is no other way. This, ladies and gentlemen, is the meaning, and hence the evolu-

tion of the Anti-Noise League . . . "Very well; in language which is more forceful than elegant, let us 'get on with it.' We do not pretend that noise constitutes the only disturbance to that nerve integrity upon which, in the last analysis, so much of our health depends. We dissipate its energy in other ways. But this is our problem, and we mean to tackle it. We work to show our fellows how they may escape from what are, literally, the hammer-blows of needless noise upon this vital tissue we call our nerves. These blows are helping to engender Fear—a sense of incapacity when faced with forces apparently beyond our control. The last enemy to be overcome in that continuity of existences which we call immortality is Death ; but the last enemy to be overcome in our own effective lifetime is Fear. Ladies and gentlemen, our aim is equanimity ; we want to explore the hygienic value of a quiet mind, if only because we ourselves have little hope that we can save civilisation without it. We believe that to achieve this the sequence must be equanimity, control, security, and for this sequence we are working.'
