DEAR MADAM,-We are directed by the Inter-Departmental Committee on the Nursing Services to inquire whether your Association would be prepared to submit for the Committee's consideration a memorandum of evidence. The terms of reference of the Committee are: "To inquire into the arrangements at present in operation with regard to the recruitment, training, registration and terms and conditions of service of persons engaged in nursing the sick and to report whether any changes in those arrangements or any other measures are expedient for the purpose of maintaining an adequate service both for institutional and for domiciliary nursing."

The Committee contemplate that after they have considered the memorandum they will determine whether your Association should be invited to give evidence orally.

The next meeting of the Committee has been fixed for January 19th, 1938, and it would be a great convenience if 40 copies of any memorandum you may desire to submit could reach us on or before January 12th.
