- 1. What signs and symptoms would lead you to suspect that an eclamptic fit was imminent? Give your management and nursing care, should a fit occur.
- 2. A patient starts to bleed after the baby is born and before the birth of the placenta. Discuss your management of such a case.
- Give an account of the anatomy of the cervix. Describe the changes which it undergoes during pregnancy, labour and the puerperium.
- 4. What is meant by the lochia? Describe the variations which may occur in the lochia during the puerperium and discuss their significance.
- 5. What steps can be taken to make lactation successful?
- What are the causes of asphyxia neonatorum? 6. State the principles of treatment.

Population Estimates for 1949.

The Registrar General issued on February 28th the second of his new series of publications giving up-to-date estimates of the populations of each local government area in England and Wales.

They are the estimates as at June 30th, 1949. They differ from those previously issued in that they include the numbers of Armed Forces stationed in each area; the previous estimates related to civilians only. It is thought that the new figures will be a better guide to most users than civilian figures. The new estimates also give the numbers of persons

under 15 years of age in each area. The population actually in this country at the date stated is estimated to be 43,595,000, with 9,497,000 under 15 years of age.
