SIR,-I have read with interest the report of the Sectional Committee on Registration of Trained Nurses to the Council of the Hospitals' Association, and find the following paragraphs with regard to Question 1—"Do you consider a general system of registration desirable for qualified nurses?" That "rather less than one-half of the replies are in the affirmative, while the bare majority (comprising, however, the leading and best known training schools) desire to be let alone." "There is every reason to believe that the following training schools concur in these opinions: The Nightingale Fund Committee (associated with St. Thomas's Hospital and other institutions), the London Hospital, Guy's Hospital, St. George's Hospital, Westminster Hospital, King's College Hospital, together with the Royal Infirmaries of Manchester, Liverpool, Glasgow, and Edinburgh." Now, sir, I should much like to know who are responsible for the answers received from the abovenamed hospitals, for I am informed that the sisters and trained nurses at some of these institutions, to whom the question is of vital importance, were not consulted in any way concerning the matter. The nursing staffs who have been individually made

acquainted with the subject, viz., at St. Bartholomew's, the Middlesex, University College, the Royal Free, Cambridge, Lincoln, Leicester, and eighty other hospitals in London, the provinces, Scotland, and Ireland, are unanimous in desiring the benefits of legal registration. I venture to consider, moreover, that it is not a question of ten hospitals being "let alone,' but what is for the ultimate benefit of the nursing profession and of the public, which has to be determined; and, furthermore, that a great national matter cannot be settled offhand by a small "Sectional Committee."
