ART. 6.—Donors are all those who take an interest in the treatment of the sick, and pay at least f r (1/8) as yearly subscription. They may attend the general meeting and take part in the discussions, but are not allowed

ART. 7.-Honorary members can be appointed by a majority of votes at the general meeting when proposed by the management or 10 members.

MANAGEMENT.

ART. 8.-The Management consists of seven Members who share the work between them.

ART. 9.- Each year two of the members of the Management retire, according to a list to be draw up. retiring members with the exception of the Secretary canment retire, according to a list to be drawu up. not be re-elected before the expiration of one year. election takes place at the general meeting from a list of candidates proposed by at least ten members, or by the management itself. The proposal of the said candidates to be made to the management six week previous to the

ART. 10. - The management represents the Association in all its affairs. It is charged to give execution to all resolutions of the general meeting, to superintend the finances, and, if necessary, to appoint committees when not already provided by the general meeting.

GENERAL MEETING.

ART. II.-An annual general meeting is to be held at which:

1. The secretary representing the management will

- give a resume of the work of the past year.

 2. The treasurer will make a statement of the financial affairs during the same period, and will offer an estimate for the ensuing year. These accounts are to be inspected by a committee consisting of three members appointed during the preceding year, and if found correct, to be laid before the General Meeting for approbation.
- 3. The filling up of vacancies in management or com-
- 4. Propositions, of which the management has acquainted the members at least 14 days beforehand, will be considered.
- 5. The time and place of next general meeting will be fixed.

ART. 12.-Propositions to be dealt with at the general meeting must be received by the management at least six weeks previously. A proposition made at the general meeting can only be dealt with if declared urgent by not less than two-thirds of the members present.

ART. 13.-In special cases, the management can arrange an extraordinary general meeting.

GENERAL RULES.

ART. 14.—The year of the Association is from the 1st

April to the 31st March.

ART. 15.—Notwithstanding the Royal approbation legally necessary, no alteration can be made in these rules unless the proposition is accepted at the general meeting by at least two thirds of the votes issued.

ART. 16.—The Association is founded for a period of 29 years, to be reckoned from the day on which the royal

approbation was granted.

Art. 17.—Should any article require further regulation for the guidance of the management, this can be arranged by mutual agreement, providing such regulation is not contrary to the rules or to Article 2 and 3 of the law of the 22nd of April, 1885 (St. C. No. 32).

ART. 18.—The dissolution of the Association can only

be resolved by a general meeting convened at 14 days notice, and can only be agreed to when supported by four-fifths of the whole number of votes.


Inventions, Preparations, &c.
