We have been requested to make public the following correspondence, and gladly do so, as we are pleased to observe that the unscrupulous attacks made upon the private character, and also the public work, of Miss Evans, have been repudiated by the Local Government Board, and her courageous conduct in acting according to the dictates of conscience, instead of adopting the usual cowardly course of condoning wrong, has earned for Miss Evans exoneration at the hands of the Local Government Board, and the gratitude and admiration not only of her colleagues, but of her sex in general.
